4. <u>BUSINESS</u>

A. AWARD BID – DEMOLITION OF ELLEN SAGAR NURSING HOME BOOSTER PUMP STATION

Utility Director Joe Nichols states that bids were received on Tuesday, January 13, 2015 at 2:00 pm for the demolition of the Ellen Sagar Booster Pump Station. Six bids were received as follows: Construction Resource Group (Union) - \$20,625; DH Griffin Wrecking Company, Inc. - \$15,000; Moats Construction Co. - \$18,475; Pump Systems Technology, Inc. - \$19,385; Smith Backhoe & Construction (Union) - \$10,665 and Welsford Investments, LLC - \$38,000. A bid summary and letter of recommendation from our consultant was presented to council. The recommendation is to award bid to low bidder and local contractor, Smith Backhoe & Construction, in the amount of \$10,665.

B. AWARD BID – 47" HYDRAULIC ROTATING DIGGER DERRICK LINE TRUCK

Utility Director Joe Nichols states that bids were received on Tuesday, December 16, 2014 at 12:00 noon for a 47-foot hydraulic rotating digger derrick with a boom tip winch mounted on a 2016 4 x 2 Freighliner M2-106 cab and chassis. Two (2) bids were received: Altec Industries - \$194,807 and Terex Utilities - \$216,797. The City of Union purchased a 2009 Altec 47-foot hydraulic rotating digger derrick and has had operation and maintenance issues since this unit was purchased. This unit has had two (2) bent outriggers which one was covered under warranty at a cost of \$15,500 and another charge in November of 2014 at a cost of \$600 which repaired some welding to a stress crack.. The recommendation is to accept bid from Terex Utilities for one new Terex Commander 4047 in the amount of \$216,797. This is a higher bid than the Altec truck but an overall better truck for the City of Union's use as explained by Mr. Nichols. It is within the approved 2014-2015 budget of \$225,000.

C. COMMUNITY CHANGE – HEATING & COOLING ASSISTANCE PROGRAM

Finance Director Walker Gallman states that since 1993, the Community Change Program has been in effect at the City of Union. What was once a way of generating funds for food and shelter to the needy is now a Heating and Cooling Assistance Program. This program began as a heating assistance program only. In August of 2011 council voted to expand the program to heating and cooling. Heating assistance (Electric and Gas) runs from January 1 thru April 30 and cooling assistance runs July 1 thru October 31. Each City of Union Customer who qualifies can receive \$100 per season. (No customer is to receive more than \$200 per year). In fiscal year 2014, the "Community Change Program" generated \$20,986.59, assisted 183 customers in the amount of \$18,224.06. In keeping with the guidelines already in place, the program will continue on the availability of funds. The Salvation Army and Carolina Community Actions have indicated with a letter of response to the City of Union that they are willing to continue the affiliation with the program by qualifying applicants for the assistance as appropriated. Letters from the two agencies agreeing to qualify applicants was presented to Council. Customers are required to participate in the Community Change program to qualify to receive assistance. Staff recommends renewing the release of Community Change funds to qualifying City Utility Customers.
